What is the purpose of processing your personal data?

How long will we hold your data?

Personal data shall be held for the periods established by law for an administrative, tax and accounting relationship, for personal contact data, these shall be held provided that the data subject does not exercise the right to deletion or objection.

What are the legal grounds for the processing of your data?

The legal grounds for the processing of your data are:

- Consent of the data subject: express and informed consent through our check box "I authorise and agree"

Who will your data be sent to?

The data is sent to the following recipients:

- provider of the website hosting and maintenance IT services for the purpose of website hosting and maintenance.
- organisations and companies of the group Olivos Naturales S.L., for the purpose of

providing the services and products requested.

Transfer of data to third countries?

No transfer of data to third countries is envisaged.

What are your rights when you provide us with your data?

Anyone has the right to obtain confirmation as to whether or not OLIVOS NATURALES S.L. is processing his/her personal data.

Data subjects have the right to access their personal data, to request the correction of any inaccurate data or, where appropriate, to request its deletion when, amongst other reasons, the data are no longer necessary for the purposes they were collected for.

In certain circumstances, data subjects may request the limitation of the processing of their data, in which case we shall solely hold the data for making or defending claims.

In certain circumstances and, for grounds relating to their particular situation, data subjects may object to the processing of their data. In this case, OLIVOS NATURALES S.L. shall stop processing the data, except for compelling legitimate grounds or defence against potential claims.

You can materially exercise your rights as follows: You have the right to access, correct and delete the data, as well as other rights, as indicated in the additional information, which you may exercise by sending an e-mail to the address: info@innoliva.com

If you have given your consent for a specific purpose, then you have the right to withdraw such consent at any time, without this affecting the legality of the processing based on the consent prior to withdrawal.

Should you feel that your rights have been infringed with regard to the protection of your personal data, particularly when you have not obtained satisfaction in the exercise of your rights, then you can file a claim with the competent Data Protection Control Authority, through its website: www.agpd.es.

HOW HAVE WE OBTAINED YOUR DATA?
